Drivers must:

- be age 21 or above
- be insured with at least the minimum amount required.
- have a current and valid driver's license.
- be able to provide each passenger with a proper seat and seat belt. (Girls under 12 years of age should sit in the back seat whenever possible to reduce the possibility of injury during the deployment of an airbag in the front passenger seat.)
