



Sensitive Issues Parent/Guardian Permission Form

Dear Parent/Guardian,

Your daughter's troop/group is planning to participate in a program or activity which involves subject matter that may be considered sensitive or controversial. The Facilitator's role is as a caring adult who can help girls acquire their own skills and knowledge in a supportive atmosphere rather than as an advocate of any particular position.

The Girl Scouts Heart of the South, in collaboration with Girl Scouts USA, has developed programs, publications and other resources to help girls deal with many of today's issues. These programs focus on a number of skills including self-esteem, communications, assertiveness, problem solving, personal safety and well-being, as well as relating to other people.

Before covering any Sensitive Issue, either within or beyond the scope of the Girl Scout program resources, your daughter's Troop Leader will obtain Council approval. We want to be sure parents are aware of the content of the program before it is presented to their girls. Therefore, written approval by a parent/guardian is required for each girl to participate in any Sensitive Issues program or activity.

Either attached or written below is information about the appropriate grade level activities proposed. Your signature gives permission for your daughter to participate with the troop/group in these activities.
